IN THE MATTER OF the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B;

**AND IN THE MATTER OF** an application by Ontario Power Generation Inc. pursuant to section 74 of the *Ontario Energy Board Act, 1998* for an order to amend its generation licence EG-2003-0104.

### PROCEDURAL ORDER NO. 1

On January 16, 2006, Ontario Power Generation ("OPG") filed an application with the Ontario Energy Board under section 74 of the *Ontario Energy Board Act, 1998*, for an order of the Board to amend Part 6 of OPG's electricity generation licence (EG-2003-0104). The Board assigned file number EB-2006-0007 to the application.

The Board issued a Notice of Application on March 14, 2006. The notice was placed on the Board's website as well as on OPG's website. The last date for intervention was March 27, 2006. The registered intervenors in this proceeding are Energy Probe Research Foundation and Hydro One Networks Inc. (collectively, the "Intervenors"). The Ontario Power Authority is a registered observer. The Power Workers' Union and Coral Energy Canada Inc. submitted letters of comment.

The Board wishes to offer Intervenors the opportunity to comment in writing on OPG's application. In making their submissions, Intervenors should have due regard to the criteria referred to in section 74(1)(b) of the Act,

namely the public interest, the objectives of the Board, and the purposes of the *Electricity Act*, 1998.

The Board considers it necessary to make provision for the following items related to this application. The Board may issue further procedural orders from time to time.

### IT IS ORDERED THAT:

- Intervenors who wish to file a written submission regarding the application shall file the submission with the Board and deliver it to OPG and all other Intervenors on or before Friday, May 5, 2006.
- OPG shall file with the Board and deliver to all Intervenors its response to the submissions on or before Friday, May 12, 2006.
- 3. All filings to the Board noted in this procedural order must be in the form of 5 hard copies and must be received by the Board by 4:45 p.m. on the stated dates. In addition to the hard copies which are filed, all parties must include a copy of their filings in Word or PDF format, either on diskette or by e-mail to boardsec@oeb.gov.on.ca.
- 4. A list of Intervenors is attached as Appendix "A" to this procedural order.
