MAKE OATH AND SAY:


1. I am a partner at McMillan LLP and counsel to the applicant Greenfield South Power Corporation (“**Greenfield**”). As such, I have knowledge of the matters contained in this Affidavit. Where my knowledge is based on information and belief, I state the source of the information and I verily believe it to be true.



LETTER OF DIRECTION

Dear Mr. Richmond:

The Ontario Energy Board has now issued its Notice ("Notice") relating to the subject application. Please note that you must comply with the following directions within fourteen days of the date of this letter. If you cannot comply with the below directions within fourteen days, you must inform the Board Secretary immediately.

Greenfield South Power Corporation is directed:

1. To remove the bold and bracketed words "[insert actual date 10 calendar days from the date the notice is posted on applicant's website]" from the Notice and insert the actual date on which the Notice will be posted on Greenfield South Power Corporation's website in accordance with the requirement in #5 of this

Letter of Direction, using the following format “**January 1, 2014**”. If the date falls on a “holiday” as defined in Rule 6.02 of the Board’s *Rules of Practice and Procedure*, insert the next date that is not a holiday.

2. To promptly, and prior to the website posting date, file with the Board a pdf version of the completed Notice.
3. To promptly, and no later than the website posting date, serve a copy of the Notice, together with a copy of the application, either personally, by courier, by e-mail or by registered mail on:
 - a. Union Gas Limited;
 - b. Enbridge Gas Distribution Inc.;
 - c. Vector Pipeline Limited Partnership; and
 - d. The Corporation of the Township of St. Clair.
4. To make a copy of the application and evidence, and any amendments thereto, available for public review at the offices of Greenfield South Power Corporation.
5. To post a copy of the Notice and the application and evidence in a prominent place on the website of Greenfield South Power Corporation.
6. To file with the Board, both electronically and in hard copy, an affidavit proving completion of the matters directed by the Board in 1 through 5 of this Letter of Direction promptly thereafter.
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

Union Gas Limited is directed:

8. To promptly post the Notice prominently on Union Gas Limited’s website, once Union has been served with the completed Notice by Greenfield South Power Corporation.

Note: This requirement is without prejudice to Union Gas Limited’s ability to determine whether and how it may participate in the current proceeding. Should

Union Gas Limited choose to participate in this proceeding, it must provide file the requisite material in accordance with the Notice.

Greenfield South Power Corporation and Union Gas Limited are further directed not to include any document(s) or material(s) when serving or posting the Notice, as applicable, other than document(s) or material(s) expressly required by this Letter of Direction.


