Ontario Energy Board to determine whether it should
order new rates for the provision of natural gas,
transmission, distribution and storage services to gas-
fired generators (and other qualified customers) and
whether the Board should refrain from regulating the
rates for storage of gas;

AND IN THE MATTER OF Rules 42, 44.01 and 45.01 of
the Board's *Rules of Practice and Procedure*.

PROCEDURAL ORDER NO. 2

The Board has received three (3) Notices of Motion from parties (the "Moving Parties") for review of separate aspects of its November 7, 2006 EB-2005-0551 Decision with Reasons in the Natural Gas Electricity Interface Review proceeding ("NGEIR").

On January 25, 2007, the Board Issued its Notice of Hearing and Procedural Order No.1 ("Notice") which established a schedule for the filing of the Moving Parties factums, any responding parties' factums, and an oral hearing date for hearing the threshold question.

The Board now considers it appropriate to make provision for the following procedural matters.

THE BOARD THEREFORE ORDERS THAT:

1. The order of appearances at the hearing for this proceeding shall be as follows:
 - a. The Moving Parties
 - i. The Consumers Council of Canada and the Vulnerable Energy Consumers Coalition
 - ii. The Industrial Gas Users Association
 - iii. The Association of Power Producers of Ontario
 - iv. The City of Kitchener
 - b. The Responding Parties
 - i. Board Staff
 - ii. Union Gas Limited
 - iii. Enbridge Gas Distribution Inc.
 - iv. Market Hub Partners Canada Ltd
 - v. School Energy Coalition
 - vi. The Independent Electricity System Operator
 - vii. BP Canada Energy Company
2. All parties shall confine their submissions to the material in their factums and to responding to the factums of other parties and shall address only the issues provided in the Board's Procedural Order No. 1, namely:
 - a. What are the threshold questions that the Board should apply in determining whether the Board should review the NGEIR Decision; and
 - b. Have the Moving Parties met the test or tests.
3. The oral hearing will commence at 9:00 am on Monday, March 5, 2007. In the event that more time is required, the Board has also reserved a second hearing day commencing at 9:00 a.m. on Tuesday, March 6, 2007. The hearing will be held in the Board's North Hearing Room on the 25th floor at 2300 Yonge Street, Toronto, Ontario.

5. Parties wishing to file supporting materials, such as Books of Authorities, must file 10 hard copies and submit a PDF file, inclusive of a table of contents. Additional copies should be made available for other participants at the hearing.
