PROCEDURAL ORDER NO. 2

- The evidentiary phase of the oral hearing will commence on Friday, July 21, 2006 at 2300 Yonge Street, Toronto in the Board's hearing room starting 9:30 a.m. The hearing is currently scheduled for up to three days ending on Tuesday, July 25, 2006.
