PROCEDURAL ORDER NO. 2

Natural Resource Gas Limited ("NRG" or the "Company") filed an Application, dated March 30, 2006, with the Ontario Energy Board under section 36 of the *Ontario Energy Board Act*, S.O. 1998, c.15, Schedule B. The Board has assigned file number EB-2005-0544 to the Application and has issued Procedural Order No.1 dated May 26, 2006.

The Board considers it necessary to make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. The Issues Conference will now be held at 2300 Yonge Street, 26th Floor, Toronto, on **Wednesday, June 7, 2006** at 11:00 a.m. Board Staff, intervenors and the Company will review the Draft Issues List that was attached in Procedural Order No.1 with the objective of developing a proposed Issues List for presentation to the Board.
2. The evidentiary phase of the oral hearing will commence on **Friday, July 21, 2006** at 2300 Yonge Street, Toronto in the Board's hearing room starting 9:30 a.m. The hearing is currently scheduled for up to three days ending on Tuesday, July 25, 2006.

3. All filings with the Board noted in the Order must be in the form of 10 hard copies and received by the Board by 5:00 p.m. on the stated date. The Board requires all correspondence to be in electronic as well as paper form.
