IN THE MATTER OF the *Ontario Energy Board Act 1998*, S.O.1998, c.15, (Schedule B);

AND IN THE MATTER OF an application by Union Gas Limited for an Order pursuant to Section 90(1) of the *Ontario Energy Board Act, 1998*, granting leave to construct a natural gas pipeline and ancillary facilities in Gorham Township and the City of Thunder Bay.

AND IN THE MATTER OF an application by Union Gas Limited for an Certificate of Public Convenience and Necessity, pursuant to Section 8 of the *Municipal Franchises Act* for Gorham Township.

PROCEDURAL ORDER NO. 2

Union Gas Limited ("Union") filed an application with the Ontario Energy Board (the "Board") dated January 17, 2006, under section 90 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (Schedule B). Union has applied for an order of the Board granting leave to construct approximately 29 kilometres of 12 inch diameter steel natural gas pipeline in Gorham Township and the City of Thunder Bay. The proposed pipeline will proceed from the existing TransCanada Pipeline Thunder Bay Metering Station located at Concession 4, Lot 6 in Gorham Township to the Ontario Power Generation Customer Station located on Mission Island in the City of Thunder Bay. The Board has assigned the leave to construct application File No. EB-2006-0004.

Union also filed an application with the Board, under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c.M.55, for an order approving a Certificate of Public Convenience and Necessity ("certificate") for Gorham Township. The Board has assigned the certificate application File No. EB-2006-0017.

The Board issued a Notice of Application and Hearing ("Notice") on February 2, 2006. Union served and published the Notice as directed by the Board. The Board's

Procedural Order No. 1 set the schedule for filing interrogatories and evidence and also ordered that the Board would proceed by way of an oral hearing.

Many parties have submitted letters of comment to the Board respecting this application. The Board invites those parties to make oral comments to the Board on the evening of Tuesday June 20, 2006.

This Procedural Order sets the dates and location of the hearing and to hear oral comments by parties who have submitted comments or other interested parties.

The Board considers it necessary to make provisions for the following items related to this application. The Board may issue further Procedural Orders from time to time.

The Board Orders That:

- 1. The hearing will commence at 9:30 a.m. on Monday, June 19, 2006 at the Prince Arthur Waterfront Hotel and Suites, 17 North Cumberland Street, Thunder Bay.
- 2. Any interested party wishing to make an oral comment to the Board shall do so on the evening of Tuesday June 20, 2006. The Board will hear these oral comments beginning at 7 p.m. ending not later than 9:00 p.m. Anyone who intends to make an oral comment shall indicate by June 16, 2006 their intention to do so, and the anticipated length of time required to make their comment, to Stephen McComb at stephen.mccomb@oeb.gov.on.ca or by telephone at 416-440-8143 or 1-877-632-6273 x143. The Board may impose limits for comments in order to ensure all participants can be accommodated in the allotted time.
