# **ONTARIO ENERGY BOARD NOTICE**

# Greenfield South Power Corporation has applied for an order granting a certificate of public convenience and necessity in relation to the construction of a natural gas system.

## Learn more. Have your say.

Greenfield South Power Corporation has entered into a Clean Energy Supply Contract with the Ontario Power Authority to construct and operate a natural gas fired power plant in St. Clair Township, Ontario. Greenfield South will construct a natural gas supply system to deliver gas to the power plant. The proposed natural gas supply system will be located on Greenfield South's property and connected to the Vector Pipeline Limited Partnership pipeline.

The *Municipal Franchises Act* requires approval of the Ontario Energy Board in the form of a certificate of public convenience and necessity prior to constructing any works to supply natural gas in any municipality. Greenfield South seeks an order of the Ontario Energy Board granting a certificate of public convenience and necessity in relation to the natural gas supply system it proposes to construct.

### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application. We will question Greenfield South on the case. We will also hear arguments from individuals and from groups that may be affected by the application. At the end of this hearing, the OEB will decide whether the certificate of public convenience and necessity should be granted.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review the application filed by Greenfield South on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by October 10, 2014 or the hearing will
  go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

#### ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings -- oral and written. Greenfield South has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why.

#### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.
