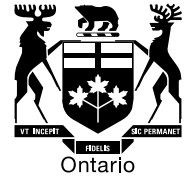

The Board has reviewed your application for a unit sub-metering licence. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Section 9, Page 5 of the Application Form – Finance:

To satisfy requirements of section 9 “Finance” you have only provided a pro forma income statement and pro forma Capitalization. Based on previous experience with similar applications, financial information provided may not be sufficient to evaluate financial viability of the applicant. Please provide a pro forma balance sheet and **assumptions** used in preparing your pro forma financial statements (Income Statement and Balance Sheet).

2. Section 10, Page 5 of the Application Form – Technical Resources:

You have answered “Yes” to the question whether the applicant employs technical resource staff with appropriate qualifications and experience in unit sub-metering. You have only provided educational background of Mr. Ghadaki and Mr. Ghanbari, while this question requires describing qualifications of at least one person employed by the applicant in relation to the services the applicant intends to provide as a licensed unit sub-metering provider. Please describe

qualifications of at least one person employed by the applicant or identify plans to acquire the necessary technical resources to provide unit sub-metering services.

3. In section 6 "Officers, Directors and Key Individuals" of the application form two key individuals have been listed. Section 12 "Key Individual Information" of the application form requires providing information for each key individual identified in section 6. You have provided information for Mr. Ghanbari only. Please provide information required in Section 12 for Mr. Ghadaki.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.
