Re: EB-2014-0012 - Union Gas Limited - Hagar Liquefaction Service Rate

Further to the letter of Northeast Midstream LP's legal counsel filed today, October 21, 2014, it is Union Gas Limited's view that Northeast has misinterpreted the intent of Union's letter filed with the Board on October 20, 2014.

It is Union's intention to file evidence in response to Northeast's motion and Union will do so on Thursday, October 23, 2014.

Northeast has made various comments its letter regarding process. With respect to process, Union proposes that the motion be heard by the Board as follows:

- the motion be heard at the outset of the proceeding on October 27, 2014
- each party filing evidence in respect of the motion will be available for cross-examination at that time
- the parties make oral submissions at the completion of the hearing of evidence in respect of the motion, or alternatively, submissions could be made as part of final submissions.

Because the motion and application are fundamentally intertwined, to avoid the delay in hearing Union's application and for efficiency before the Board, Union proposes that the proceeding not be adjourned pending the Board's determination on the motion. Instead, Union proposes that the Board hold in abeyance its determination on the motion and proceed with the hearing of Union's application as follows:

• the Board not require interrogatories in respect of Union's evidence update filed on October 9, 2014 as parties are able to ask further questions as part of cross examination of Union's witnesses during the proceeding and the evidence update is not extensive • Union's application be heard by the Board (together with the motion) on October 27 and 28.

Union believes that the foregoing provides a clear and fair process to all parties and requests that the Board proceed accordingly.
