

# ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF NIAGARA PENINSULA ENERGY INC.

**Niagara Peninsula Energy Inc. has applied to raise its electricity distribution rates.**

**Niagara Peninsula Energy Inc. has applied to the Ontario Energy Board to increase the amount it charges by \$0.81 each month for the typical residential customer beginning on May 1, 2015. Other customers, including businesses, may be affected as well.**

## **THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING**

The Ontario Energy Board (OEB) will hold a public hearing to consider Niagara Peninsula's request. We will question the company on its case for a rate increase. We will also hear arguments from individuals and from groups that represent Niagara Peninsula customers. At the end of this hearing, the OEB will decide what, if any, increase will be allowed.

Distributors such as Niagara Peninsula typically apply for a full review of their rates every five years. Any rate changes for the years in between are made by applying a formula that is tied to inflation and other factors intended to promote efficiency. You may not get notice of future rate changes made by applying the formula.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

## **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process. You can:

- review Niagara Peninsula's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by **[insert actual date 10 calendar days from publication]** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

## **LEARN MORE**

These proposed charges relate to Niagara Peninsula's distribution services. They make up part of the Delivery line -- one of the five line items on your bill.
