Union Gas Limited has applied for approval to construct natural gas pipeline, ancillary facilities and a compressor station and for approval to recover costs associated with this development

Union Gas Limited applied for approval to construct a pipeline, ancillary facilities and a compressor station to expand its Dawn to Parkway transmission system in 2016. The proposed expansion is located in the City of Hamilton, the City of Burlington, the Town of Milton and the Municipality of Middlesex Centre. Union Gas also applied for approval of recovery of costs associated with construction of the proposed transmission system expansion.

A map of the proposed expansion is provided below.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Union Gas. We will question Union Gas on the case. We will also hear arguments from individuals and from groups that represent the customers of Union Gas. At the end of this hearing, the OEB will decide whether to approve the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review the application filed by Union Gas on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by **[insert actual date 10 calendar days from publication]** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under sections 36, 90(1) and 91 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
