# Enbridge Gas Distribution Inc. has applied for approval of the Dawn Access Settlement Agreement.

Enbridge Gas Distribution Inc. has filed with the Ontario Energy Board the Dawn Access Settlement Agreement, which sets out the terms upon which Enbridge's customers will be given access to transportation service at the Dawn Hub in Southwestern Ontario. The Settlement Agreement was developed through a broad consultation process.

**Enbridge Gas Distribution requested that the Ontario Energy Board approve:** 

- (1) the Dawn Access Settlement Agreement;
- (2) the methodology for the calculation of the Dawn Transportation Service Charge; and
- (3) the establishment of the Dawn Access Costs Deferral Account.

#### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The OEB will hold a public hearing to consider Enbridge Gas Distribution's application. We will review the Dawn Access Settlement Agreement and may question the company on its case. We will also hear arguments from individuals and from groups that represent Enbridge Gas Distribution's customers. At the end of this hearing, the OEB will decide whether to approve the request.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process. You can:

- review Enbridge Gas Distribution's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply no later than [insert actual date 7 calendar days from the date the Notice is posted on the applicant's website] or the hearing will go ahead without you and you will not receive any further notice of the proceeding.

#### As part of your request to become an intervenor you must include the following:

- a) whether you would like to ask Enbridge written questions (interrogatories) in relation to the application; and
- b) whether you would like to make a formal submission in relation to the application; and
- c) whether you think an oral hearing is needed and if so, the reasons that you think an oral hearing is needed in this case.
- at the end of the process, review the OEB's decision and its reasons on our website.
