We are counsel to HQ Energy Marketing Inc. (“HQEM”) in the above captioned matter. HQEM is the Canadian power marketing subsidiary of Hydro-Québec. Hydro-Québec is one of North America’s largest electric utilities – it is involved in transmission, distribution and generation of electricity from renewable energy sources, and in particular hydroelectricity. HQEM is a participant in the Ontario energy market, and sells into, buys from, and wheels energy through Ontario to other neighbouring control areas.

HQEM participated in Hydro One’s previous transmission rates proceeding, EB-2012-0031. HQEM also participated in the negotiation of the settlement agreement filed by Hydro One in this proceeding, and is a party to the settlement agreement.
