Re: EB-2014-0251: Superior Plus LP (Superior Plus) Gas Marketer Licence Renewal Application

Reply Submissions

On July 25, 2014 Superior Plus filed an application for renewal of its gas marketer licence (GM-2012-0448) for a term of 5 years.

The transmittal letter filed with the application also included a request, on behalf of Superior Energy Management Gas LP (Superior Gas), that the Superior Gas licence (GM-2012-0038) be amended to shorten its term by adjusting its current expiry date (May 30, 2017) to December 31, 2015.

Together, these two requests are intended to respond to concerns expressed by the Board in its EB-2012-0448 decision which renewed Superior Plus' licence for only an 18 month term. In that earlier decision the Board stated its expectation that during the 18 month Superior Plus licence renewal term the various entities in the *Superior Energy Management* group would rationalize their gas supply and customer service arrangements so that only one of the two gas marketing licences would ultimately continue.


Board Staff, the only other party to this proceeding, filed its final submission on October 29th. After reviewing the materials filed by Superior, Staff concludes its submission as follows:

Board staff submits that the steps taken by Superior Plus and Superior Gas to transition to one licence and Superior Plus' commitment to complete the transition by December 31, 2015 support granting Superior Plus its gas marketer licence renewal for the full five year term. Board staff further submits that simultaneously Superior Gas' licence GM-2012-0038 be amended to have its term reduced to December 31, 2015.

Superior Plus and Superior Gas endorse these conclusions by Staff, and have no further submissions to make.

The applicants therefore ask that the Board proceed to determine the applications, grant Superior Plus a 5 year renewal of its licence (GM-2012-0448) and amend Superior Gas' licence (GM-2012-0038) to expire December 31, 2015, all as explained in our applications transmittal letter dated July 24, 2014.
