Enbridge Gas Distribution Inc. has applied to the Ontario Energy Board for approval to dispose of amounts recorded in certain deferral or variance accounts which it says will have the following estimated impact on a typical customer's total bill:

- For residential customers served under Rate 1 an increase of \$1.00 per year.
- For commercial customers served under Rate 6 a credit of \$2.00 per year.

Other customers, including businesses, may also be affected.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The OEB will hold a public hearing to consider Enbridge Gas's request. We will question the company on its case. We will also hear arguments from individuals and from groups that represent Enbridge Gas's customers. At the end of this hearing, the OEB will decide whether to approve all or any part of the request.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Enbridge Gas Distribution's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by [insert actual date 10 calendar days from the date the notice is posted on the applicant's website] or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.
