Toronto Hydro writes to the Ontario Energy Board (“OEB”) in respect of the above-noted matter.

Pursuant to Procedural Order No. 1 issued September 17, 2014, please find enclosed an electronic version of Toronto Hydro’s Interrogatory Responses. Ten physical copies of the Interrogatory Responses will follow shortly via courier.

Toronto Hydro received interrogatories from Board Staff, AMPCO, BOMA, CCC, CUPE, SEP, and the SIA on October 15, 2014. Toronto Hydro received interrogatories from SEC and VECC on October 17.

Toronto Hydro notes that BOMA did not follow the OEB’s filing convention in providing its interrogatories, in that the interrogatories were not sorted by evidence exhibit and numbered sequentially. In order to maintain reference formatting consistency with other parties, Toronto Hydro has, on a best efforts basis, mapped the BOMA interrogatories to an evidence exhibit, based on the evidence references provided within each interrogatory. Due to the original ordering provided (which Toronto Hydro has not changed), these interrogatories will not appear sequentially.

Toronto Hydro has provided responses to all interrogatories with the exception of 1A-VECC-1, which requests a summary of the revenue requirement impacts of any adjustments made during the interrogatory process. Toronto Hydro must undertake a detailed review of all of its responses in their

final form in order to prepare this summary. As such, Toronto Hydro intends to provide a response to this interrogatory shortly, and in advance of the Technical Conference scheduled for November 17 and 18.

Certain interrogatories received by Toronto Hydro requested excel or other data files. Where applicable, Toronto Hydro has provided these files with the filenames indicating the interrogatory to which they correspond.

In addition, two interrogatory responses contain confidential information. Under separate cover, Toronto Hydro requests that these responses be treated confidentially, pursuant to the OEB's *Rules of Practice and Procedure* and the OEB's *Practice Direction on Confidential Filings*.
