**IN THE MATTER OF** the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B (the "Act");

**AND IN THE MATTER OF** an application by Greenfield South Power Corporation for a certificate of public convenience and necessity, pursuant to section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M. 55.

**PROCEDURAL ORDER NO. 2**  
**November 7, 2014**

The Ontario Energy Board received an application from Greenfield South Power Corporation ("Greenfield") for a Certificate of Public Convenience and Necessity ("Certificate") under section 8(1) of the *Municipal Franchises Act* on September 18, 2014, with amendments filed on September 25, 2014 ("Greenfield's Certificate Application").

The Board granted intervenor status to Union Gas Limited ("Union") and the Ontario Power Authority. A Notice of Application was issued on September 26, 2014 and served and published as the Board directed.

The Board issued Procedural Order ("PO") 1 on October 28, 2014 attaching an Issues List and setting the timeline for a written discovery process including opportunity for intervenors and Board staff to file evidence by November 5, 2014, interrogatories on that evidence by November 12, 2014 and for interrogatory responses by November 19, 2014.

On November 5, 2014 Greenfield filed supplementary evidence which it states addresses issues on the Issues List that were not covered in the original pre-filed evidence. On November 5, 2014 Union filed a letter requesting that the supplementary evidence not be accepted by the Board and if accepted requesting additional time to review the supplementary evidence and file its evidence. On November 6, 2014 Greenfield filed a letter with the Board supporting Union's request to allow additional time for review of the supplementary evidence.

The Board finds that the supplementary evidence is within the scope of the proceeding and that it provides a more complete record on the issues set out in the Issues List. The

Board therefore accepts the supplementary evidence and finds that it is reasonable to allow additional time for Board staff and the parties to review the supplementary evidence.

A record of all procedural matters that have been dealt with up to this point in this proceeding is available on the Board's web site.

The Board considers it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. Intervenor and or Board staff who wish to present evidence shall file that evidence with the Board and deliver it to Greenfield, the intervenors and Board staff no later than **November 14, 2014**.
2. Anyone who requires additional information related to the application, , any intervenor evidence, and/or Board staff evidence, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Greenfield, intervenors and Board staff on or before **November 21, 2014**.
3. Responses to the interrogatories on the application, intervenor and/or Board staff evidence shall be filed with the Board and delivered to Greenfield, intervenors and Board staff on or before **November 28, 2014**.

All filings to the Board must quote the file number, EB-2014-0299, be made electronically in searchable / unrestricted PDF format through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
