 - b. Insert the actual date, which date shall be determined by adding 10 calendar days to the date that the Notice will be posted on Hydro One's

website in accordance with the requirements of paragraph 4 below. If that actual date falls on a "holiday" as defined in Rule 6.02 of the Board's *Rules of Practice and Procedure*, insert the next date that is not a holiday. Use the following date format "**January 1, 2014**".

- 2. Once the date is known, to immediately and prior to serving the Notice in accordance with paragraph 3 or posting the Notice in accordance with paragraph 4, file with the Board a pdf version of the complete (dated) Notice.
- 3. To, no later than the date the Notice is posted on Hydro One's website in accordance with paragraph 4, serve a copy of the complete (dated) Notice and the application and evidence, directly on electricity distributors and other transmission customers served by Hydro One Networks Inc. (Transmission); on all licenced transmitters in Ontario, on all intervenors of record in its previous transmission rate application proceeding (EB-2012-003), and on the intervenors of record in the East-West Tie Line proceeding (EB-2011-0140).
- 4. To make a copy of the complete (dated) Notice, application and evidence, and any amendments thereto, available for public review at Hydro One Network Inc.'s office and in a prominent place on its website.
- 5. To file with the Board an affidavit proving service of the Notice and that a copy of the Notice, application and evidence are available for public review at Hydro One Networks Inc.'s office and on its website.
- 6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this Letter of Direction to be served.
