AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. for an order granting a certificate of public convenience and necessity to construct works to supply gas in the Town of Grand Valley (formerly known as the Township of East Luther Grand Valley) of Dufferin County;

APPLICATION

Parties

- 1. Enbridge Gas Distribution Inc. (the "Applicant") is an Ontario corporation with its head office in the City of Toronto.
- 2. The Corporation of the Town of Grand Valley (the "Municipality") is a municipal Ontario corporation with its head office at 5 Main Street North, Grand Valley, Ontario.

History

3. The Municipality was formed as the result of an amalgamation effective January 1, 1995 of the former Township of East Luther and the former Village of Grand Valley and in September 2012 a name change was made to the Town of Grand Valley. Attached as Schedule "A" is a map showing the geographical location of the Municipality.

4. The Applicant possesses a certificate of public convenience and necessity (the "Certificate") permitting it to distribute, store and transmit gas in the parts of the Municipality comprising the geographical area of the former Township of East Luther Grand Valley (pursuant to certificate No. EBC 224).

Attached hereto and marked as Schedule "B" is a copy of the aforementioned Certificate.

- 5. The Applicant wishes to replace its existing Certificate with a certificate of public convenience and necessity to construct and to operate works for the distribution of gas in the whole Municipality, as required for present and future public convenience and necessity.
- 6. The Applicant possess a franchise agreement permitting it to distribute, store and transmit gas in the parts of the Municipality comprising the geographical areas of the former Township of East Luther Grand Valley (pursuant to By-law No. 95-29).

Attached hereto and marked as Schedule "C" is a copy of the aforementioned By-Law.

7. The Applicant wishes to replace its existing franchise agreement and enter into a municipal franchise agreement with the Municipality, in the form of the Ontario Energy Board ("Board") approved 2000 Model Franchise Agreement, with no amendments. Attached hereto and marked as Schedule "D" are: the signed Resolution from the Town of Grand Valley; the form of the Municipality's By-law granting to the Applicant the municipal franchise; and a copy of the proposed municipal franchise agreement between the Applicant and the Municipality (the "Franchise Agreement").

Relief Requested

- 8. The Applicant hereby applies to the Board for:
 - i. an order, pursuant to Section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M. 55, as amended (the "Act"), for a certificate of public convenience and necessity to construct works to supply gas in the Municipality;
 - ii. an order, pursuant to Section 9 of the Act, granting the Applicant the right to construct or operate works for the distribution of gas, and the right to extend or add to the works, in the Municipality for such period of time and upon such terms pursuant to the provisions of the Franchise Agreement in Schedule "D" attached, or as may otherwise be prescribed by the Board.
 - iii. an order, pursuant to Section 9 of the Act, directing and declaring that the assent of the municipal electors to the terms and conditions of the franchise agreement is not necessary.

9. The persons affected by this application are the customers and other residents in the Municipality. Because of the number of such persons, it is impractical to set out their names and addresses herein.
