AND IN THE MATTER OF an application by Innisfil Hydro Distribution Systems Limited for an order approving just and reasonable rates and other charges for electricity distribution to be effective January 1, 2015.

PROCEDURAL ORDER NO. 4 November 18, 2014

Innisfil Hydro Distribution Systems Limited ("Innisfil Hydro") filed an application with the Ontario Energy Board (the "Board"), on August 13, 2014 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Innisfil Hydro charges for electricity distribution, to be effective January 1, 2015.

Procedural Order No.2 made provisions for a technical conference, a settlement conference and dates for an oral proceeding. The oral hearing was scheduled to either review a proposed settlement agreement or examine all aspects of Innisfil Hydro's request for an incremental capital module.

The Parties reached an agreement on Innisfil Hydro's request to recover costs of its new headquarters and a Settlement Proposal was filed on November 12, 2014.

Procedural Order No. 3 provided procedural steps for Argument-in-Chief, submission and reply submissions on all aspects of the Price Cap IR application.

The Board considers it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

- 1. An oral hearing, previously scheduled on **November 20, 2014**, is cancelled.
- 2. Board staff and the Parties shall make submissions and reply submissions in accordance with the schedule set out Procedural Order No. 3.
