AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. for an order or orders approving the final balances and for clearance of certain Demand Side Management Variance Accounts into rates, within the next available QRAM following the Board's approval

PROCEDURAL ORDER NO. 1 November 19, 2014

Enbridge Gas Distribution Inc. ("Enbridge") filed an application with the Ontario Energy Board (the "Board") dated October 2, 2014 under section 36 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, (Schedule B) (the "Act"), for an order or orders approving the final balances in certain 2013 Demand Side Management ("DSM") Deferral and Variance Accounts. Enbridge is also seeking the disposition of the balances in these accounts, and inclusion into rates, within the next available Quarterly Rate Adjustment Mechanism following the Board's approval. The Board has assigned file number EB-2014-0277 to the application.

The accounts which are the subject of the application and the balances recorded are as follows:

DSM Incentive Deferral Account	\$4,538,188 (to shareholder)
Lost Revenue Adjustment Mechanism Variance Account	(\$50,317) (to ratepayers)
DSM Variance Account	(\$3,601,806) (to ratepayers)

The net balance of the DSM Accounts is \$886,065 to be collected from ratepayers.

Enbridge has also applied to the Board for such final and interim orders and/or accounting orders as may be necessary in relation to clearance of the accounts which are the subject of this application.

Intervenors

The Board issued a Notice of Application and Hearing on October 31, 2014. The following parties applied for intervenor status and cost eligibility:

- Building Owners and Managers Association, Greater Toronto ("BOMA");
- Canadian Manufacturers & Exporters ("CME"); and
- Energy Probe Research Foundation ("EP").

Each of BOMA, CME and EP is granted intervenor status. The list of parties in this proceeding is attached as Appendix "A" to this Procedural Order. I have also determined that BOMA, CME, and EP are eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards*.

Confidentiality

Enbridge filed redacted and confidential un-redacted versions of its application. Enbridge requested that the redacted information in the areas listed below be maintained in confidence pursuant to the Board's *Practice Direction on Confidential Filings* (the "Practice Direction") and Rule 10 of the Board's *Rules of Practice and Procedure*:

- Exhibit B, Tab 5, Schedule 1 Custom Project Savings Verification Report prepared by MMM Group Ltd.
- Exhibit B, Tab 5, Schedule 2 Custom Project Savings Verification Report prepared by Gevinar Inc.

Enbridge stated that information has been redacted where it might reveal the identity of program participants, the location of participating facilities, and their internal processes and operations. Enbridge further stated that these are either matters of privacy or commercial sensitivity, that it has committed to protect such information, and that it is the expectation of custom program participants that this information will be protected. Furthermore, Enbridge stated that its future efforts to attract program participants could be prejudicially impacted if such information is released publicly.

I direct Enbridge to provide confidential versions of the evidence to counsel and consultants for intervenors who have signed the Declaration and Undertaking form from the Board's Practice Direction. A process for the filing of written submissions on whether the information which is currently redacted should remain confidential or be made public is provided in the Order below.

I consider it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- 1. Any party, including Board staff, may file a written submission on whether the information filed confidentially should remain confidential or be placed on the public record of this proceeding on or before **December 3, 2014.**
- 2. Enbridge may file a written reply to any written submission from parties or Board staff on or before **December 17, 2014.**
- Intervenors and Board staff may request from Enbridge any relevant information and documentation that is in addition to the evidence already filed through written interrogatories filed with the Board and served on all parties on or before December 3, 2014.
- 4. Enbridge shall file with the Board complete written responses to all interrogatories and serve them on all intervenors and Board staff on or before **December 17, 2014**.

All filings to the Board must quote the file number, EB-2014-0277, and be made electronically through the Board's web portal at https://www.pes.ontarioenergyboard.ca/eservice/, in searchable / unrestricted PDF format. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at http://www.ontarioenergyboard.ca/OEB/Industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
