3. If Lakefront Utilities Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
4. To make a copy of the Notice available for public review at Lakefront Utilities Inc.'s office and in a prominent place on its website;
5. To file with the Board an affidavit proving publication, service and website posting of the Notice immediately thereafter;
6. To make a copy of the application and evidence, and any amendments thereto, available for public review at Lakefront Utilities Inc.'s office and in a prominent place on its website; and
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
