**RATE ORDER
RIDER E**

November 27, 2014

Enbridge Gas Distribution Inc. ("Enbridge") filed an application dated July 3, 2013 with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act, S.O. 1998* for an order or orders approving rates for a five year period commencing January 1, 2014. The Board assigned file number EB-2012-0459 to the application. A record of all procedural matters in this proceeding is available on the Board's web site.

In accordance with the Board's Decision and Rate Order dated August 22, 2014, Enbridge filed a submission on November 12, 2014 pertaining to the Rider E amount. Rider E, the "Revenue Adjustment Rider" is required because the final approved rates for 2014 were lower than the interim rates in place between January 1, 2014 and September 30, 2014. As a result, Enbridge has collected extra revenue that needs to be returned to customers. Rider E is designed to return the extra revenue collected. The Board in its August 22, 2014 Decision and Rate Order directed that the Rider E amount be calculated on the basis of actual volumes for the January to September period as opposed to forecast volumes which was the proposal made by Enbridge. The

Board also directed that the Rider E amount be refunded in conjunction with the January 1, 2015 QRAM process as a one-time disposition in January 2015.

The Board has reviewed the materials filed in Enbridge's November 12, 2014 submission and finds that it meets the direction provided in its August 22, 2014 Decision and Rate Order. The Board therefore expects the disposition to proceed as planned in January 2015 and finds that it is appropriate to issue this Rate Order.

THE BOARD ORDERS THAT:

1. The unit rates attached as Appendix A to this Order and identified as Rider E Revenue Adjustment Rider are hereby approved. The unit rates are effective January 1, 2014 and shall be implemented on January 1, 2015.
