**DECISION AND ORDER**  
**November 27, 2014**

TransCanada Energy Ltd. ("TransCanada") filed an application on October 8, 2014 with the Ontario Energy Board pursuant to section 74 of the *Ontario Energy Board Act, 1998* ("the Act") to amend its electricity generation licence EG-2009-0024 and a request to subsequently cancel electricity generation licence EG-2012-0393 issued to 2176050 Ontario Inc. and electricity generation licence EG-2012-0416 issued to 2225249 Ontario Inc. pursuant to section 77(5) of the Act.

The requested amendment is to add to Schedule 1 of TransCanada's electricity generation licence two solar generation facilities, namely Brockville 2 located in

Brockville, Ontario and Burritts Rapids located in Merrickville, Ontario. The requested addition of these facilities is as a result of the acquisitions of 2176050 Ontario Inc. and 2225249 Ontario Inc. by TransCanada by way of a share transfer agreements. Both generation facilities will be transferred to TransCanada as of November 30, 2014.

TransCanada has also requested subsequent cancellation of electricity generation licences currently held by 2176050 Ontario Inc. and 2225249 Ontario Inc.

I have proceeded to decide the application without a hearing pursuant to section 21(4)(b) of the Act since no other parties are adversely affected in a material way by the outcome of the proceeding, and the applicant has consented to disposing of the application without a hearing.

I find that it is in the public interest to grant the requested amendment to TransCanada's electricity generation licence and cancel 2176050 Ontario Inc.'s electricity generation licence and 2225249 Ontario Inc.'s electricity generation licence.

**IT IS THEREFORE ORDERED THAT:**

1. Schedule 1 of TransCanada Energy Ltd.'s electricity generation licence EG-2009-0024 will be amended to add generation facilities Brockville 2 and Burritts Rapids to the licence.
2. 2176050 Ontario Inc.'s electricity generation licence EG-2012-0393 will be cancelled.
3. 2225249 Ontario Inc.'s electricity generation licence EG-2012-0416 will be cancelled.
