We will also hear arguments from individuals and from groups that have a direct interest in the application. At the end of this hearing, the OEB will decide whether to approve the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review the application filed by Enbridge on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by [insert actual date 10 calendar days from the date the notice is posted on applicant's website] or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

This hearing will be held under sections 36.2(1)(b) and 38 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
