Re: EB-2014-0337 - Motion to Review and Vary Decision and Order

We are counsel to East Durham Wind LP ("East Durham") in the above noted proceeding. On December 2, 2014, legal counsel to the Municipality of West Grey provided us with a letter (a copy of which is enclosed) expressing the Municipality's acceptance of the distribution system location modifications that East Durham had proposed in its November 12, 2014 filing with the Board (the "Location Modifications").

Given this consensus, and given that the Municipality is the sole owner of the road allowances in which the distribution system (as modified) will be located, we respectfully request that the Board grant the Location Modifications and discontinue the proceeding, given that section 1(b) of the Board's December 23, 2013 Revised Decision and Order in EB-2013-0233 states the distribution shall be located 1-4 metres from the abutting property line unless otherwise agreed to between East Durham and the Municipality.

Re: East Durham Wind, LP - Collection Line Route Modifications and Request for Ontario Energy Board to Initiate a Motion for Reviw and Vary Revised Decision and Order in EB-2012-0233

As discussed during our most recent telephone call yesterday, we are advised that the Municipality has now completed its review (in detail) of the materials originally provided by Mr Rickel in October. It has also had an opportunity to review the Request you filed with the Board.

The Municipality is not opposed to the modifications to the location of the collection lines proposed in your materials, which modifications it understands to be identified on the accompanying maps as:

- 1. Additional Collection Corridor Blue Cross Hatching; and
