

# ONTARIO ENERGY BOARD NOTICE

## Canadian Niagara Power Inc. has applied to the Ontario Energy Board to change its electricity transmission revenue requirement.

Canadian Niagara Power Inc. has applied to the Ontario Energy Board to change the amount it recovers from customers in 2015 and 2016 and to approve its customer delivery point performance standards. Canadian Niagara Power Inc. is requesting a revenue requirement decrease in 2015, followed by an increase in 2016. Typical residential customers' bills will not change as a result of the requests because Canadian Niagara Power Inc.'s total requested revenues constitute less than 0.5% of the total cost of transmission in Ontario. Other customers, including businesses, may be similarly affected.

#### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Canadian Niagara Power Inc.'s request. We will question the company on its revenue requirement. We will also hear arguments from individuals and from groups that represent customers in Ontario. At the end of this hearing, the OEB will decide what level of revenue requirement will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Canadian Niagara Power Inc.'s application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by **December 22, 2014** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.
