Dear Sirs:

it appears to us that your windmills will be forced onto Amherst Island despite their unwillingness.

Resident's objections come from fear that the island will be destroyed with those monsters which are reported to make residents sick, destroy nature life and the landscape.

My wife and me, family and friends and acquaintances will not travel to destinations like that in order to escape even those effects: getting sick from windmills, seeing dead bodies of birds and suffering of nature and the unnatural ugly high industrial towers and the complaints of sick human beings. Tourism we expect will be suffering and businesses as well.

May we please ask for an oral hearing on Amherst Island so that the Board and the Applicant understand the reality of Island living and the high risks presented by the Windlectric Inc. application and

may we ask also to send us reports of monitoring your application so that we are provided with all documents ?

We herewith inform you that we object to the application based on the significant differences submitted to the Ministry of the Environment and Climate Change by Windlectric in its Renewable Energy Approval application and to the Ontario Energy Board in its Application for Leave to Construct

We like to point out that the project is not cost-effective based on the economic and risk analysis prepared by Dr. John Harrison

Please inform us also what those windmills are costing Ontario consumers, because Wind and solar power are providing less than 4% of Ontario's power but account for 20% of what we Ontarians pay, according to the Fraser Institute. The report suggests the Ontario government could prevent further electricity rate increase by halting all new hydroelectric, wind and solar projects. To reduce rates, the province could terminate, where possible, existing contracts between renewable energy companies and the Ontario Power Authority.

We express also our concern about the risk of interrupting the power supply to the

Island, marine accidents, industrial accidents including well known fire danger from overheating oil quantities in the mills, spills, impact on groundwater, risk to schoolchildren.

We support the Little's request to reject or greatly alter the project so that their home is not surrounded by turbines, a hydro substation, a cement batching plant, a maintenance building, and significant heavy equipment and truck traffic.

We hope that who will read this can read and consequently listen to objecting people which are more than upset about this situation, which seems to endanger not only Amherst Island but does have far reaching effects in this corner of Ontario.

Please be fair and reasonably ! If you do this kind of industrial work, plan it ahead in industrial areas but not in nature-sensitive ones like Amherst Island !
