Hi Christiane, I have reviewed the changes to the model noted below and agree with them.

Will there be a final chance to update the tariff sheet once the final RTSR rate adjustments are made? For example, the tariff sheet within the model defines the unit of measure as \$/kW for the 'Rate Rider for the Disposition of the Global Adjustment (2015)' whereas it should be \$/kWh for all rate classes for this rate rider. I have to manually adjust the 'separate file' for the tariffs to refine this. As long as there is another opportunity to do this once the final rates are determined I am satisfied.
