AND IN THE MATTER OF an application by Union Gas Limited for an order or orders granting leave to construct natural gas pipelines and ancillary facilities in the Township of St. Clair, in the County of Lambton.

PROCEDURAL ORDER NO. 1
December 11, 2014

The Ontario Energy Board received an application on November 4, 2014 under section 90(1) of the Act from Union Gas Limited ("Union") for a leave to construct 4.8 kilometers of NPS 20 natural gas pipeline. The proposed pipeline will extend from Union's Payne Storage Facility to the Sarnia Industrial Line System in the Township of St Clair, in the County of Lambton. The proposed pipeline will allow Union to ensure the continued reliable, safe delivery of natural gas and serve the growing Sarnia market.

The Board issued a Notice of Application ("Notice") on November 13, 2014. Union posted and served the Notice in accordance with the Board's directions.

NOVA Chemicals (Canada) Ltd. ("NOVA") filed a letter with the Board on December 1, 2014 seeking intervenor status in the proceeding.

Union requested that the Board hear the application by way of a written hearing. NOVA agreed with Union's request.

Provision is being made for written submissions following the filing of interrogatory responses, unless the Board orders otherwise during the course of the proceeding. The Board may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. NOVA is granted intervenor status in this proceeding.
2. The list of parties in this proceeding is attached as Appendix "A" to this procedural order.
3. Board staff and NOVA shall request any information and material from Union that is in addition to Union's pre-filed evidence with the Board, and that is relevant to the hearing, by written interrogatories filed with the Board and served on Union on or before **December 19, 2014**.
4. Union shall file with the Board complete written responses to the interrogatories and serve them on all intervenors on or before **January 9, 2015**.
5. Unless the Board orders otherwise, Board staff and NOVA shall file any written submission by **January 23, 2015**. Any submission should be filed with the Board and delivered to Union and NOVA.
6. Unless the Board orders otherwise, Union may file a written reply submission with the Board, and deliver it to the NOVA by **February 6, 2015**.

All filings to the Board must quote the file number, EB-2014-0333 and be made electronically in searchable/unrestricted PDF format through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
