**IN THE MATTER OF** the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B;

**AND IN THE MATTER OF** an application by Union Gas Limited for an order varying the conditions of approval in EB-2008-0038 and EB-2009-0144 relating to the allowable pressure gradient in each of Enniskillen 28, Oil City Pool and Oil Springs East natural gas storage pools in the Townships of Enniskillen, St. Clair, and in the County of Lambton.

**PROCEDURAL ORDER NO. 1  
December 18, 2014**

The Ontario Energy Board received an application from Union Gas Limited ("Union") on October 1, 2014 under 38(1) and 40(1) of the Act for leave to operate its Oil City, Oil Springs East and Enniskillen 28 natural gas storage pools at a maximum pressure gradient of 17.2 kPa/m (0.76 psi per foot) as permitted under the CSA Standard Z341.1-14. This request requires the conditions of approval issued in the EB-2008-0038 and EB-2009-0144 proceedings to be varied to increase the operating pressure gradient.

The Board issued a Notice of Application ("Notice") on October 31, 2014. Union posted and served the Notice in accordance with the Board's directions. Enbridge Gas Distribution Inc. ("Enbridge") filed a letter with the Board on November 19, 2014 seeking intervenor status in the proceeding.

No party expressed a preference to oral vs. written hearing.

Provision is being made for written submissions following the filing of interrogatory responses, unless the Board orders otherwise during the course of the proceeding. The Board may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. Enbridge is granted intervenor status in this proceeding.
2. The list of parties to this proceeding is attached as Appendix "A" to this procedural order.
3. Board staff and Enbridge shall request any information and material from Union that is in addition to Union's pre-filed evidence with the Board and that is relevant to the hearing by written interrogatories filed with the Board and served on Union on or before **December 23, 2014**.
4. Union shall file with the Board complete written responses to the interrogatories and serve them on Enbridge on or before **January 6, 2015**.
5. Unless the Board orders otherwise, Board staff and Enbridge shall file any written submission by **January 13, 2015**. Any submission should be filed with the Board and delivered to Union and Enbridge.
6. Unless the Board orders otherwise, Union may file a written reply submission with the Board, and deliver it to the Enbridge by **January 16, 2015**.

All filings to the Board must quote the file number, EB-2014-0306 and be made electronically in searchable/unrestricted PDF format through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
