**IN THE MATTER OF** the Ontario Energy Board Act, 1998, S.O. 1998, c.I5, Schedule B (the "Act");

AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. under sections 36.1(1)(b) and 38 of the Act for an order or orders amending the designated storage area of the Chatham 7-17-XII Pool in the Municipality of Chatham-Kent.

### PROCEDURAL ORDER NO. 1 December 19, 2014

The Ontario Energy Board received an application on November 19, 2014 under sections 36(1)(b) and 38 of the Act from Enbridge Gas Distribution Inc. ("Enbridge") for approval to expand the boundaries of the Chatham 7-17-XII designated storage area located in the Municipality of Chatham-Kent.

The Board issued a Notice of Application on December 1, 2014. Enbridge posted and served the Notice in accordance with the Board's directions.

Union Gas Limited ("Union") requested intervenor status in the proceeding.

Enbridge requested that the Board hear the application by way of a written hearing. No party requested an oral hearing.

Provision is being made for written submissions following the filing of interrogatory responses, unless the Board orders otherwise during the course of the proceeding. The Board may issue further procedural orders from time to time.

#### IT IS THEREFORE ORDERED THAT:

1. Union is granted intervenor status in this proceeding.

- 2. The list of parties in this proceeding is attached as Appendix "A" in this procedural order.
- 3. Board staff and Union shall request any information and material from Enbridge that is in addition to Enbridge's pre-filed evidence with the Board, and that is relevant to the hearing, by written interrogatories filed with the Board and a copied to Enbridge and Union on or before **December 23, 2014**.
- 4. Enbridge shall file with the Board complete written responses to the interrogatories on or before **January 9, 2015**.
- 5. Unless the Board orders otherwise, Board staff and Union shall file any written submission on or before **January 21**, **2015**. Any submission should be filed with the Board and copied to Enbridge.
- 6. Unless the Board orders otherwise, Enbridge may file a written reply submission with the Board on or before **January 26, 2015**.

All filings to the Board must quote the file number, EB-2014-0288 and be made electronically in searchable/unrestricted PDF format through the Board's web portal at <a href="https://www.pes.ontarioenergyboard.ca/eservice/">https://www.pes.ontarioenergyboard.ca/eservice/</a>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="http://www.ontarioenergyboard.ca/OEB/Industry">http://www.ontarioenergyboard.ca/OEB/Industry</a>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
