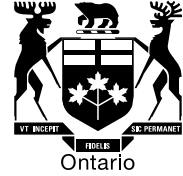

The Ontario Energy Board "OEB" received SparkleLight LP and BluEarth Asset Management Inc.'s applications for amendments to Schedule 1 of Electricity Generation Licences EG-2013-0362 and EG-2014-0200 on January 16, 2015. The OEB has assigned file number EB-2015-0014 and EB-2015-0015, respectively to the applications. The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the Ontario Energy Board Act, 1998 (the "Delegated Authority"). The Delegated Authority intends to make a decision on the applications without holding a hearing.

If required, OEB staff will contact you directly to seek clarification regarding the applications and/or request additional information or material to complete the applications. For these purposes, OEB staff may contact you by email, regular mail, or by telephone. Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
