The Board has reviewed the record of this application and determined that the information listed below is required in order to complete the record.

 In its pre-filed evidence (Exh B, Tab 1, Sch 1, p. 1), OPG stated that it is applying on behalf of itself and Coral Rapids Power Limited Partnership ("CRP"), who are finalizing a partnership agreement.

Please provide an update regarding the OPG-CRPLP agreement.

2. In its pre-filed evidence (Exh B, Tab 1, Sch 1, p. 2), OPG stated that "the Ontario Minister of Energy issued a directive to the Ontario Power Authority ("OPA") directing the OPA to enter into negotiations for a power purchase agreement with OPG to procure electricity from OPG and the Taykwa Tagamou First Nation proposed 25 megawatt New Post Creek hydroelectric generating station."

Please advise whether the OPA (now IESO) has executed a power purchase agreement regarding the subject generation with OPG and if so, provide proof of such agreement. If a power purchase agreement has not been executed, please provide the status of the agreement as well as a copy of the Ministerial directive.

OPG has submitted that addendums to the previously filed System Impact
Assessment Report ("SIA") and Customer Impact Assessment Report ("CIA")
are currently in progress with the Independent Electricity System Operator
("IESO) and Hydro One, respectively.

Please provide the status of the SIA and CIA addendums and copies of the documents when available

Note that the SIA and CIA reports are fundamental documents that the Board relies on with respect to quality and reliability of electrical service. Therefore, the Board will not issue a decision in this case prior to OPG's filing of the amended SIA and CIA reports.

Please provide the information requested by February 2, 2015.
