AND IN THE MATTER OF an application by TransAlta Corporation, TransAlta Generation Partnership and TransAlta Cogeneration L.P. for certain preliminary determinations of the Ontario Energy Board in regard to the interpretation of the T1 / T2 contract.

NOTICE OF APPLICATION AND PROCEDURAL ORDER NO. 1 January 27, 2015

TransAlta Corporation, TransAlta Generation Partnership and TransAlta Cogeneration L.P. (TransAlta) filed an application dated December 3, 2014 seeking Ontario Energy Board (OEB) determinations on three preliminary issues relating to the interpretation of the T1 / T2 contract and the alternative dispute resolution requirements applicable to contracts for transportation services.

TransAlta specifically requested that the OEB consider the following three preliminary issues.

- Does the OEB have, and will it exercise, jurisdiction to determine the correct interpretation of TransAlta's Daily Contract Quantity (DCQ) obligations under its T1 / T2 contract?
- 2) If the OEB determines that it <u>does</u> have jurisdiction to determine the correct interpretation of TransAlta's DCQ obligations under its T1 / T2 contract, does the OEB have, and will it exercise, jurisdiction over the amounts that may be owed to TransAlta under the T1 / T2 contract?

3) If the OEB determines that it <u>does not</u> have jurisdiction to determine the correct interpretation of TransAlta's DCQ obligation under its T1 / T2 contract, will the OEB refer TransAlta's application to binding arbitration in accordance with the *Storage and Transportation Access Rule* (STAR)?

The OEB received a letter from Union Gas Limited (Union) on January 5, 2015 responding to TransAlta's application. TransAlta filed a response to Union's letter on January 12, 2015. Union filed another letter responding to TransAlta's response on January 21, 2015.

The OEB will adopt Union as an intervenor in this proceeding. A list of intervenors for EB-2014-0363 is attached as Appendix "A" to this order.

The OEB will hear TransAlta's application by way of an oral hearing. Accordingly, the OEB will make provisions for the following procedural matters. Further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

- 1. The parties listed in Appendix "A" are granted intervenor status in the proceeding.
- 2. An Oral Hearing will be held on March 17, 2015 beginning at 9:30 a.m. in the Board's Hearing room, on the 25th floor at 2300 Yonge Street, Toronto, Ontario. The Board expects that, at the outset of the Oral Hearing, TransAlta will provide an opening statement, after which, parties wishing to make oral argument will be provided an opportunity to do so. Finally, TransAlta will be granted an opportunity to reply to the arguments of other parties.
