As outlined in the case management letter issued November 13, 2014, the Board's Vice President, Applications has been delegated authority under Section 6 of the *Ontario Energy Board Act, 1998* to make a decision on the 2015 Annual IR Index application filed by EnWin Utilities on October 31, 2014. All relevant information and updates to the application have now been provided.

Attached to this letter is a draft of the decision the delegated authority proposes to make based on the application and any subsequent updates or clarifications. The draft decision proposes to approve the disposition for all Group 1 Accounts, excluding Account 1589 – Global Adjustment, over a 9-month period from August 1, 2015 to April 30, 2016. The disposition period for Account 1589 – Global Adjustment is proposed to be over 12-months from May 1, 2015 to April 30, 2016.

The Vice President, Applications has included findings which require EnWin Utilities to recalculate its rate riders for its Group 1 Accounts, excluding Account 1589 – Global Adjustment, to include projected interest to July 31, 2015.

The accompanying draft Rate Order includes the rate riders for Account 1589 over a one year period (i.e. May 1, 2015 to April 30, 2016). The remainder of the rate riders for EnWin Utilities' Group 1 Deferral and Variance accounts are those as initially filed. The revised rate riders reflecting the additional interest will be incorporated into the final Decision and Order.

Please review the decision and provide any comments. Please also review the accompanying draft Rate Order for accuracy and completeness, excluding the aforementioned rate riders. Any comments are to be provided no later than March 5, 2015.

The Vice President, Applications will consider your comments, if any, provided they have been received by the deadline, and issue a final decision and rate order in due course.
