## PROCEDURAL ORDER NO. 2 February 20, 2015

Enbridge Gas Distribution Inc. (Enbridge) filed an application dated November 28, 2014 with the Ontario Energy Board (the OEB) under section 36 of the *Ontario Energy Board Act, S.O. 1998* for an order or orders approving rates commencing January 1, 2015 (the Application).

The OEB issued its Procedural Order No. 1 on January 12, 2015 in which it scheduled, among other things, a Technical Conference to be held on February 25, 2015. The Technical Conference follows the interrogatory responses which Enbridge filed on February 19, 2015.

The OEB is in receipt of an email from Enbridge dated February 19, 2015 sent to the OEB and the parties requesting that parties advise Enbridge if they believe that the Technical Conference is required. Enbridge also requested that if the Technical Conference is required, then it would like advance notice of the topic areas to be addressed at the Technical Conference so that it may bring the appropriate witnesses. Enbridge said it would inform the OEB if no stakeholders believed the Technical Conference is required.

The OEB finds Enbridge's request reasonable and will provide a formal process for parties to respond to the request.

The OEB may issue further procedural orders from time to time.

## THE OEB THEREFORE ORDERS THAT:

 Any parties or OEB staff wishing the Technical Conference to proceed shall file a letter to that effect with the OEB and provide a copy to all other parties no later than Noon, Monday, February 23, 2015 and shall include in such letter the topic areas they intend to address at the Technical Conference.

All filings to the Board must quote the file number, **EB-2014-0276** and be made electronically in searchable/unrestricted PDF format through the Board's web portal at <u>www.pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed.

Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>www.ontarioenergyboard.ca/OEB/Industry</u>.

If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
