**REQUEST FOR INTERVENOR STATUS

This includes any revisions or amendments, which may be made prior to the commencement of or during the hearing of this Application. Union's preference is to receive searchable electronic versions of filings in this proceeding.
5. At this time, it is Union's intention to monitor the proceeding; however, after reviewing the evidence, Union may wish to address one or more of the issues.

6. Union reserves the right to adduce evidence, submit interrogatories, cross-examine witnesses, advance argument and participate in the hearing as circumstances may require.
