Union's preference is to receive searchable electronic versions of filings in this proceeding.
- 5. At this time, it is Union's intention to monitor the proceeding; however, after reviewing the evidence, Union may wish to address one or more of the issues.

- 6. Union reserves the right to adduce evidence, submit interrogatories, cross-examine witnesses, advance argument and participate in the hearing as circumstances may require.
