RE: EB-2015-0035 – Union Gas Limited – April 1, 2015 QRAM Application

This letter is in response to information requests by Board Staff regarding Union's April 1, 2015 QRAM application (EB-2015-0035). Union confirms that any variances between the NEB final approved and interim approved tolls will be captured in the relevant deferral accounts for future disposition.

Upstream Transportation Toll Changes

Please see Attachment 1 for the NEB approved TCPL Abandonment Surcharge tolls effective January 1, 2015. The Abandonment Surcharge tolls in Attachment 1 are added to the EB-2014-0356 approved tolls to arrive at the April 1, 2015 tolls in Working Paper, Schedule 4, page 1.

Please see page 20 for the TCPL SS. Marie to Union SSMDA toll (\$0.05158/GJ/Month). This change represents the difference between line 7 column (f) and line 7 column (h) of Union's Working Papers, Schedule 4, page 1.

Please see page 25 for the TCPL Union Dawn to Union CDA (Parkway) toll (\$0.0128/GJ). This change represents the difference between line 48 column (f) and line 48 column (h) of Union's Working Papers, Schedule 4, page 1.

Please see page 30 for the TCPL Union EDA STS Withdrawal toll (\$0.52893/GJ/Month). This change less \$0.181/GJ (which was incorrectly included in the Union Dawn Receipt Point Surcharge in the January 2015 QRAM and was corrected and trued up in this QRAM) represents the difference between line 45 column (f) and line 45 column (h) of Union's Working Papers, Schedule 4, page 1.

The difference between the CTHI/CPMI January and April QRAM is \$3.942/GJ. Only the CTHI portion of this toll has an Abandonment Surcharge. Please see Attachment 2 for the CTHI toll. The Abandonment toll for CTHI is \$152.481/10³m³/Month (or \$4.016/GJ/Month) as shown at Attachment 2, page 2. The variance between the

Abandonment Surcharge toll of \$4.016/GJ and the difference between column (f) and column (h) on Working Papers, Schedule 4, page 1, line 8 of \$3.942/GJ is related to the change in heat value effective April 1, 2015 which affects conversions in the tolls. CTHI requires a conversion from $\$/10^3\text{m}^3$ to $\$/\text{GJ}$ and CPMI requires a conversion from $\$/\text{MCF}$ to $\$/\text{GJ}$.

The Canadian Manufacturers & Exporters (“CME”) and the Industrial Gas Users Association (“IGUA”) submitted letters to the Board on Union’s April 1, 2015 QRAM application. CME and IGUA had no objections to the approval of the April 1, 2015 QRAM application.

ORDER AO-01-TGI-001-2014

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF a compliance filing filed with the National Energy Board (Board) by TransCanada PipeLines Limited (TransCanada) dated 25 November 2014, pursuant to MH-001-2013 and Order MO-029-2014 under File No. OF-AF-SAC 04 (Compliance Filing).

BEFORE the Board on 17 December 2014.

WHEREAS the Board approved proposed tolls set out in an application by TransCanada, dated 12 December 2013 and heard in RH-001-2014, on an interim basis effective 1 January 2015 and issued Order TGI-001-2014;

WHEREAS TransCanada filed the Compliance Filing dated 25 November 2014, seeking approval of abandonment surcharges and tariff amendments pursuant to the MH-001-2013 Reasons for Decision and Order MO-029-2014;

THEREFORE, IT IS ORDERED pursuant to subsection 19(2) and Part IV of the Act, that:

TransCanada's current Mainline interim tolls, which were made effective as of 1 January 2015 under Toll Order TGI-001-2014, be varied on an interim basis to include the proposed abandonment surcharges, annual contribution amount and tariff amendments, as presented in the Compliance Filing, pending any future amending Order and/or final Order by the Board concerning Mainline tolls for 2015 to 2020.

Proposed 2015 Abandonment Surcharges
Effective January 1, 2015 **Subject to NEB Approval**

- Notes: (i) On May 29, 2014, the NEB issued the MH-001-2013 decision directing all pipelines to begin collecting an abandonment surcharge on January 1, 2015 to fund the future cost of pipeline abandonment. The proposed surcharges must be filed with the NEB by December 5, 2014, at which point they will be subject to NEB approval. Given the uniqueness of this circumstance and its importance to shippers, TransCanada is providing the level of the surcharge it intends to file in advance of the NEB filing.
- (ii) The following transportation services are subject to the Abandonment Surcharges: FT, FT-NR, STS, STS-L, FT-SN, MFP, IT, STFT, and ST-SN. The Daily Equivalent Abandonment Surcharge is only applicable to IT, STFT, ST-SN, ARPs, Diversions and STS Overrun.
- (iii) Transportation with receipt points from delivery areas or Spruce is for STFT and IT service only.
