Enbridge Gas Distribution Inc.

Application for approval to drill two natural gas injection/withdrawal wells in the Wilkesport designated storage area in the Township of St. Clair in Lambton County.

PROCEDURAL ORDER NO. 1 March 19, 2015

Enbridge Gas Distribution Inc. (Enbridge) filed an application dated December 17, 2014 with the Ministry of Natural Resources and Forestry (MNRF) for two well drilling licences in the Wilkesport designated storage area. The application was referred to the Ontario Energy Board (OEB) by the MNRF on January 29, 2015, pursuant to section 40 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (schedule B).

A Notice was issued on February 11, 2015 and was served and published as directed. The OEB did not receive any requests for intervenor status.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff may request any information and material from Enbridge that is in addition to Enbridge's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and served on Enbridge by **March 25, 2015**.
- 2. Enbridge shall file with the OEB complete written responses to the interrogatories by **April 1, 2015**.
- 3. Unless the OEB orders otherwise, OEB staff shall file any written submission with the Board and copy Enbridge by **April 10, 2015**.

4. Unless the OEB orders otherwise, Enbridge may file a written reply submission with the OEB by **April 15, 2015**.

All filings to the OEB must quote the file number EB-2014-0378 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <u>www.pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
