In the Ontario Energy Board's ("OEB") Letter of Direction (the "Direction") dated March 6, 2015, the OEB directed Pembina to comply with the Direction within fourteen days. Accordingly, we enclose the following materials for filing:

- 1) Affidavit of Melissa Lundy, sworn March 18, 2015, demonstrating completion of items 1 through 5 of the Direction.

With regards to item 5, copies of the completed Notice, the location map, Pembina's Application and evidence and any amendments there to were made available for public viewing on March 13, 2015 and March 18, 2015 at Pembina's Calgary and Corunna offices respectively..

- 2) Affidavit of Heather Thompson, of Elexco Ltd., sworn March 18, 2015, demonstrating completion of item 3 of the Direction.

In accordance with Rule 10 of the Ontario Energy Board's *Rules of Practice and Procedures*, Pembina is e-filing a redacted version of this Affidavit for the OEB's e-public records and Pembina requests the OEB treat the redacted sections of this Affidavit as confidential.
