Entegrus Powerlines Inc. ("Entegrus") has reviewed the Board's Decision and Order issued March 19, 2015 in respect of the above noted file. Entegrus confirms that the draft Tariff of Rates and Charges as shown in Appendix A is complete and accurate, with the exception of the following items:

- Appendix A, Page 10 of 42: Entegrus notes the narrative description of this Service Charge should read as follows: "Standby Charge – for a month where standby power is not provided."
- Appendix A, Page 11 of 42: Entegrus notes that the rate associated with the Chatham-Kent Sentinel Lighting Service Classification for the "Rate Rider for Disposition of Historic Global Adjustment Account (2015) effective until April 30, 2016, Applicable only for Non-RPP Customers and excluding MUSH customers" should be "\$/kW (0.0854)" per the "Entegrus DVADisposition 20150319.xlsx" file.
- Appendix A, Page 15 of 42: Entegrus notes that the loss factors are not accurately shown. The previously approved loss factors that should be listed are as follows:
 - Total Loss Factor Secondary Metered Customer < 5,000 kW 1.0428
 - Total Loss Factor Secondary metered Customer > 5,000 kW 1.0430
 - Distribution Loss Factor Primary Metered Customer < 5,000 kW 1.0324
 - Distribution Loss Factor Primary Metered Customer > 5,000 kW 1.0141

Entegrus respectfully requests the Tariff of Rates and Charges be updated for these minor exceptions.
