Re: Active Energy Corp. GM-2012-0044

Active Energy Corp. is seeking an amendment to its natural gas marketer licence (GM-2012-0044). The licence amendment it requests is to use the name Active Business Services as a trade name of Active Energy Corp. As the trade name indicates (i.e., the word Business in its name), the name Active Business Services would only be used when retailing to business electricity consumers. Attached is the Master Business Licence for Active Business Services.

As per section 21(4)(b) of the Ontario Energy Board Act, Active Energy Corp. consents to disposing of the proceeding without a hearing, and is of the opinion that the use of this trade name does not adversely affect any persons and any of Active Energy's existing customers.; since consumer enter into all retailing commodity contracts with Active Energy Inc. for electricity commodity and/or Active Energy Corp. for natural gas commodity and not Active Business Services.

Please note that Active Energy Inc. (the electricity retailing company of Active Energy) will be requesting the same amendment to its electricity retailer licence (ER-2012-0045).

As outlined in the Board's Licence Amendment procedures, Active Energy is providing the following updated information.

1. Change of Contact Name for Licensee:

(i) The primary contract is still Michael A. Stedman; however, his title has changed to President of Active Energy.
