Application to determine the location of electricity distribution facilities within road allowances owned by the County of Lambton

PROCEDURAL ORDER NO. 2

April 2, 2015

Suncor Energy Products Inc. (Suncor) filed an application with the Ontario Energy Board (OEB) on November 25, 2014, under subsection 41(9) of the *Electricity Act*, *1998*, S.O. 1998, c. 15, Schedule A, as amended (Electricity Act) for an order or orders establishing the location of Suncor's proposed distribution facilities within certain road allowances owned by the County of Lambton (County) because Suncor and the County have not been able to agree on the location of these distribution facilities.

The County applied for and was granted intervenor status. In its intervention request, the County recommended that an interrogatory conference or technical conference be held prior to the consideration of Suncor's application. The OEB established instead a process for the parties to file supplemental evidence and written interrogatories to clarify any of the evidence. This process was completed on March 26, 2015.

The OEB has decided that it will be useful for the parties to clarify any remaining issues through a technical conference. The OEB has also determined that it will proceed with a written hearing.

The OEB considers it necessary to make provision for the following matters related to this proceeding.

IT IS THEREFORE ORDERED THAT:

- 1. A transcribed technical conference will be held on **April 22, 2015** at the OEB offices at 2300 Yonge Street, 25th floor at 9:30 am.
- 2. Suncor shall file its argument-in-chief, if any, with the OEB and deliver it to all parties on or before **April 27, 2015.**
- 3. Intervenors and OEB staff shall file any final argument with the OEB, and copy all parties, on or before **May 4, 2015.**
- 4. Suncor shall file any reply submission with the OEB and copy all parties on or before **May 11, 2015.**

All filings to the OEB must quote the file number, EB-2014-0355 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <u>https://www.pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at
