**Re: Notice of Proposal Under Section 81 of the *Ontario Energy Board Act, 1998*
as submitted by Kruger Energy Inc. (the "Notice")
Board File Number EB-2007-0691**

We are counsel to Kruger Energy Inc. ("KEI") in the above-stated matter.

We write in order to request an adjournment of the Technical Conference scheduled for Thursday, June 12, 2008. Given the very recent introduction of proposed changes to the Standard Offer Program by the Ontario Power Authority, KEI is of the view that it would be premature to discuss the technical aspects of the proposed Substation before the consultations on the proposed draft changes to the program are concluded. Changes proposed include the amount a proponent could connect per TS and the amount per developer per technology that could be connected prior to commercial operation. KEI understands that the consultations themselves could lead to further changes to the proposed rules. The recent proposed changes if approved could have significant implications with respect to generation projects that could connect to the proposed Substation and consequently certain components of the Substation as currently proposed.

KEI understands from the RESOP Technical Session #1 of June 2, 2008 that the OPA is targeting the week of August 25, 2008 for the release of new RESOP rules and new contract. KEI is proposing that the Technical Conference take place after consultation has concluded and the new rules are established.

KEI is mindful of the amount of effort and work which will be expended in preparing for and attending at the Technical Conference. In order to make the Technical Conference as productive as possible, KEI takes the view that the specifics of the proposed project should be reviewed once the revised RESOP rules are established.
