Application for leave to construct a natural gas pipeline and ancillary facilities in the Town of Milton and the Town of Oakville and for approval to recover the cost consequences of the development of the proposed Burlington Oakville Project.

**NOTICE OF MOTION TO COMPEL FURTHER AND BETTER
INTERROGATORY RESPONSES
AND PROCEDURAL ORDER NO. 2
April 9, 2015**

Union Gas Limited (Union) filed an application with the Ontario Energy Board (OEB) on December 12, 2014 to construct a pipeline and ancillary facilities in the Town of Milton and the Town of Oakville (Burlington Oakville Project) and for approval to recover the cost consequences of the development of the proposed Burlington Oakville Project.

A Notice of Application was issued on January 13, 2015 and was served and published as directed. On February 19, 2015 the OEB issued Procedural Order No. 1 which set the schedule for the hearing.

On March 26, 2015 Union filed its responses to interrogatories from Board staff and intervenors.

On April 4, 2015 Ontario Greenhouse Vegetable Growers (OGVG) filed a motion to compel Union to respond fully to certain OGVG interrogatories (the Motion). OGVG requested that Union provide more information in order to allow intervenors to gain a better understanding of the range of potential alternatives to the proposed project considered by Union, including alternative collaborative solutions among Union, TransCanada PipeLines Limited and Enbridge Gas Distribution Inc. OGVG indicated that Union's responses to the interrogatories are insufficient to examine this issue and inhibits the development of intervenor evidence that OGVG says would be of assistance

to the OEB. OGVG requested that the OEB order a written process to receive submissions from parties on the merits of compelling Union to provide full answers to certain interrogatories. If the Motion were to be granted by the OEB, OGVG proposed a Technical Conference be held to address the issue and obtain the information on the record.

On April 7, 2015 Canadian Manufacturers and Exporters filed a letter in support of the Motion including a request for a Technical Conference. On April 8, 2015 the Association of Power Producers of Ontario filed a submission in support of the Motion.

The OEB will consider written submissions on the merits of the Motion. The date for the filing of intervenor evidence and the dates for subsequent procedural steps, as set out in Procedural Order No. 1, are suspended. The OEB will issue a further procedural order once the hearing of the Motion is completed.

THE OEB ORDERS THAT:

1. OGVG shall file with the OEB and deliver to Union any additional material in support of the Motion by **April 16, 2015**.
2. Intervenors and OEB staff may file written submissions on the merits of the Motion with the OEB and deliver them to all intervenors and Union by **April 23, 2015**.
3. Union may file a written reply submission with the OEB and deliver it to all the intervenors by **April 30, 2015**.
4. The date for the filing of intervenor evidence and the other dates for subsequent procedural steps, set out in Procedural Order No. 1, are suspended. The OEB will issue a further procedural order once the hearing of the Motion is complete.

All filings to the OEB must quote file number **EB-2014-0182**, be made through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available you may email your document to the BoardSec@ontarioenergyboard.ca. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper

copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the OEB's web portal an e-mail is not required.
