IN THE MATTER OF the *Ontario Energy Board Act* 1998, S.O.1998, c.15, (Schedule B);

AND IN THE MATTER OF an Application by Hydro One Networks Inc., for an order or orders granting Leave to construct transmission facilities in Norfolk County for the Vanessa - Norfolk Transmission Reinforcement Project.

PROCEDURAL ORDER NO. 1

Hydro One Networks Inc. (the "Applicant") has filed an application with the Ontario Energy Board (the "Board") dated March 13, 2008 under section 92 of the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B. The Applicant has applied for an order or orders of the Board granting leave to construct transmission facilities for the Vanessa - Norfolk Transmission Reinforcement Project. The work involves reinforcing the existing 12 km 115 kilovolt ("kV") single-circuit transmission line in Norfolk County between Vanessa Jct. and Norfolk Transformer Station by:

- replacing the existing conductors with higher capacity conductors;
- installing a new set of conductors to establish a second 115 kV circuit on the existing structures; and
- constructing a short (20 metre) line tap to connect Bloomsburg Municipal
 Transformer Station to the 115 kV line.

The Board has assigned File No. EB-2008-0023 to this application.

The Board issued a Notice of Application and Hearing on March 28, 2008. The Notice was published and served by the Applicant as directed by the Board. An intervenor list is attached as Appendix "A" to this Procedural Order.

The Board has decided to proceed with this case by way of a written hearing. However, the Board may hold an oral hearing for any component of the application should the Board find it necessary.

The Board considers it necessary to make provision for a number of procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

- Intervenors and Board staff who wish information from the Applicant that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the Applicant and the other Intervenors on or before Friday, May 23, 2008.
- The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors on or before **Monday**, **June** 2, 2008.
- 3. Intervenors and Board staff who wish to make a submission on the application must file that submission with the Board, and deliver it to the Applicant and other intervenors on or before **Thursday**, **June 12**, **2008**.
- 4. If the Applicant wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors on or before **Monday**, **June 23**, **2008**.
- 5. All filings to the Board must quote file number EB-2008-0023. If you already have a user ID, please submit your responses through the Board's web portal at www.errr.oeb.gov.on.ca. Additionally, two paper copies are required. If you do not have a user ID, please visit the Board's website under e-Filing and fill out a user ID password request. For instructions on how to submit and naming conventions please refer to the RESS Document Guidelines found at www.oeb.gov.on.ca, e-Filing Services. The Board also accepts responses by email, and again, two additional paper copies are required. Those who do not

have internet access are required to submit their intervention request on a CD or diskette in PDF format, along with two paper copies. The Board's e-mail and mailing addresses are given in Appendix A.
