THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The OEB will hold a combined public hearing to consider Union Gas Limited's and Enbridge Gas Distribution Inc.'s requests. We will question the companies on their respective demand side management (conservation) plans. We will also hear arguments from individuals and from groups that represent Union Gas Limited's and Enbridge Gas Distribution Inc.'s customers. At the end of this hearing, the OEB will decide whether the proposed demand side management (conservation) plans and the resulting rate impacts are reasonable.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this combined proceeding and to be involved in the process.

You can:

- review both Union Gas Limited's and Enbridge Gas Distribution Inc.'s applications on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by **May 5, 2015** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

If you write a letter of comment or sign up to observe the hearing, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and e-mail address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under section 36(1) of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
