**PROCEDURAL ORDER NO. 1**  
**April 29, 2015**

On March 11, 2015 Hudson Energy Canada Corp. (“Hudson Energy”) applied under section 50 and section 60 of the *Ontario Energy Board Act, 1998* (the “Act”) for a Gas Marketer Licence and Electricity Retailer Licence. The granting of these licences would enable Hudson Energy to market natural gas and retail electricity to customers in Ontario.

A Notice of Application and Written Hearing was issued on March 26, 2015 which established deadlines for the filing of interrogatories and submissions by interested parties and for responses by the Applicant.

On April 24, 2015 Board staff filed interrogatories on the application evidence. On April 24, 2015 Hudson Energy requested an extension of the time allotted to file the responses to those interrogatories. Hudson Energy requested the extension due to the fact that it is currently preparing its year end reporting and a number of key individuals are heavily focused and involved in this activity.

Given the importance of having a thorough and complete record of the application I find that a provision should be made for an extension of time for Hudson Energy to respond to Board staff’s interrogatories.

Accordingly, I find it necessary to make provision for the following procedural matters. This Procedural Order may be amended, and further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. The applicant shall file with the Board complete written responses to the interrogatories no later than **May 22, 2015**.
2. If Board staff wishes to make a submission, it must file this submission with the Board, and deliver it to the applicant by **June 5, 2015**.
3. If the applicant wishes to file a response to a submission this must be filed with the Board by **June 19, 2015**.

All filings to the Board must quote the file number EB-2015-0124 and EB-2015-0125, and consist of one electronic copy in searchable / unrestricted PDF format made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/> and two paper copies delivered to the Board's offices at the address below. Filings must clearly state the sender's name, postal address and telephone number and e-mail address. Parties should use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
